Exhibitors and Owners of Terriers Entered Must Be Current JRTCA Members (Does not apply to other breeds)

GENERAL RULES FOR ALL EXHIBITORS

1. All sanctioned classes are open to Jack Russell Terriers only.

2. Exhibitors and owners of terriers entered must be current JRTCA members, and must not be a member of a conflicting JRT organization or register their JRTs in any all-breed registry or conflicting JRT registry. If an exhibitor is found to be in violation of this policy, entry will be disqualified and no refunds will be given. If a violation is confirmed after the trial, placements will be voided from all JRTCA records. Exhibitors must submit a completed entry form including a signed waiver for every trial they enter.

3. Entries MUST be within the 10-15" JRTCA height standard for all sanctioned classes (with the exception of pups who have not yet met the 10" height standard); measuring devices will be available on the trial grounds.

4. Puppies (under 12 months of age) are not eligible for a championship in any division but their own. Puppies are eligible to compete only if they have reached their four-month birthday (not 16 weeks). A puppy's age is the actual age the pup is on the day of the trial.

5. Bitches in season may not compete in any division. Pre-entry fees of bitches in season to be refunded with vet certificate from owner, or as otherwise agreed upon by the Trial Chairperson.

6. Spayed or neutered terriers may compete in Miscellaneous Conformation. They may not compete in Puppy, Family*, Open or Working Conformation. *Note: For Family Classes, Brood Bitches and Stud Dogs entered may not be spayed/neutered. The offspring at their sides may be intact or spayed/neutered.

7. A terrier bred by a sanctioned JRTCA Judge may not be shown under that Judge in the Conformation Division.

8. Terriers owned or co-owned by the Trial Chairperson, or any member of their household, may not be entered in any phase of the competition, with the exception of Child and Youth Handling classes.

9. Terriers owned by Judges may not be entered in the division in which they are judging, but may enter the competition in any other division.

10. Terriers owned by Stewards may be entered in any division provided that they find a substitute to perform their duties or have someone else show their terriers.

11. Requests for the measurement of a terrier entered in any class number may be made only by another exhibitor in that same class number or by the Judge EXCEPT in Racing. Requests for the measurement of a terrier in Racing may be made by the Judge or by an exhibitor with a terrier entered in the same class number; OR, if classes are split by gender, may call for the measurement of a terrier of the opposite gender in the same age and height category. (Example: The owner of an under adult dog entered in Racing may call for the measurement of a number adult bitch as the potential exists for them to race each other in the Championship Races.) Exhibitors racing puppies may call for the measurement of a puppy in a different age category as long as it is in the same height category. The person making the request for measurement must name the terrier or terriers they wish to have measured, but requests for measurement of entire classes will not be honored. The measurement of the terrier will be considered the terrier's official height for the duration of the trial. Only JRTCA height cards issued after September, 1999 will be honored.

12. Excessive use of squeaky or fur-like baiting devices by exhibitors is prohibited in the Conformation ring and may result in the exhibitor being excused from the class. "Excessive use" will be at the Judge's discretion.

13. Exhibitors participating in the JRTCA Working Terrier classes or Certificate Go-To-Ground/Super Earth must submit the appropriate JRTCA certificates with pre-entries or at the time of post-entry. The Judge may require a copy of the certificate be presented to the Ring/Den Steward at the time of judging. Registered terriers may submit a copy of NHC application signed by a JRTCA Working Judge within 30 days of the date it was issued.

14. Puppies under the age of three months are not permitted on the trial grounds. Any person violating this rule will be excused from all classes entered, and asked to leave the trial site. (This applies to RVs & campers, if at the same address as the trial grounds).

15. All dogs must be leashed or crated except when competition requires off leash work. No liberty leashes allowed

16. Overly aggressive dogs, or an owner's failure to control their dog, may result in disqualification at the discretion of the Judges or the Trial Chairperson.

17. The abuse of dogs or severe disciplining of dogs on the trial grounds is prohibited. Anyone displaying such behavior will be asked to leave the trial site, and no entry fees will be refunded.

18. Dogs other than JRTs on the grounds may be excluded or permitted at the discretion of the Trial Chairperson.

19. Exhibitors are responsible to double-check the classes they have entered and be on time. No refunds will be given for missed classes.

20. The owner/handler of a terrier entering any class does so at his/her own risk and agrees to abide by the rules of the JRTCA and the trial. A copy of the JRTCA Rule Book can be obtained by contacting the JRTCA office 410-561-3655; or it can be downloaded from the JRTCA website (www.therealjackrussell.com).

21. Unsportsmanlike conduct, or the use of foul and abusive language, will not be tolerated. Anyone demonstrating such conduct will be asked to leave the trial site and no entry fees will be refunded. In addition, such conduct will be subject to penalties, which may include the suspension of membership, restriction from entering the JRTCA National Trial, and/or fines. Trial Chairpersons have the right to refuse any entry at their sole and absolute discretion.

22. All dogs brought to JRTCA Sanctioned Trials must be current on vaccinations. No dogs of any age may be brought to a trial who have suspicion of contagious or infectious diseases.

23. Judges must not eat, smoke, or use cell phones while at their events. (01/22)

24. THE JUDGE'S DECISION CONCERNING PLACEMENTS ARE FINAL IN ALL DIVISIONS!

IMPORTANT TRIAL INFORMATION

Please familiarize yourself with the notes and rules listed below. Everything will run more smoothly if everyone knows the information provided.

As of Jan. 1, 2010, all competing terriers must be registered or recorded with the JRTCA. If your terrier has not been registered or recorded, you will have to pay an additional \$5.00 per dog per day. You still have to pay the normal \$2.00 per dog per day JRTCA Administration Fee. Both fees are turned in to the JRTCA.

<u>***ENTRIES MUST BE POSTMARKED BY</u> <u>MONDAY, MAY 23, 2022***</u>

All entries postmarked after 5/23/2022 will be considered post-entries, and you will be charged accordingly. No Exceptions. NO PHONE ENTRIES. Please email entries to the Trial Secretary at <u>plrjacks@gmail.com</u>, (or regular mail - see entry form), along with copies of your <u>current</u> JRTCA Membership card, & any applicable Certificates. <u>EMAILED</u> ENTRIES MUST BE RECEIVED BY FRIDAY, MAY 27TH. All emailed entries will receive a confirmation email, if you have not received your confirmation by June 4, please contact the Trial Secretary.

<u>CERTIFICATES</u>: Please include copies of the necessary certificates with your pre-entries for the Working Division, GTG, Super Earth and any other class(es) requiring certificates. The trial secretary makes no assumptions. If the appropriate certificate is not included, your dog will be entered in the open class -- NOT the certificate class.

PLEASE REMEMBER TO PICK UP AFTER YOUR DOGS WHILE AT THE TRIAL SITE

If you see someone who does not, <u>politely</u> offer them a baggie.

REMINDER: Please follow the rules of your hotel/accommodations regarding your terriers; clean up after them on the grounds and please be a good representative of your club.

It is the intent of club members to provide a trial that is enjoyable for all participants. As a result, **UNSPORTSMANLIKE CONDUCT WILL NOT BE TOLERATED** at any time. Anyone demonstrating poor sportsmanship, rude behavior or causing trouble in any manner will be dismissed from all classes and asked to leave the trial grounds. No refunds will be given in this situation.

MEASUREMENTS of borderline-sized terriers or disputed terriers will be performed by a sanctioned judge a minimum of 30 minutes before **Racing** or **Conformation** starts. Conformation measurements will be performed by the Conformation judge or their designee **before** the start of Conformation classes. The judge, however, may call for a measurement once a class begins. Measurements made at this time will be considered the terriers' official height for the duration of the trial.

RINGSIDE SPACE: Available for the weekend for \$30.00 Members / \$35.00 Non-Members for a 10 X 10 space. Ringside Seating will be assigned. **ONLY 10 Spaces Available**. Reservations will be on a first come basis. There is plenty of open space to set up.

There are also 5' X 8' Stalls available inside of the Goat barn directly across from the Conformation Ring. Each Stall is \$5 for the weekend. Stalls will be assigned on a first come basis. X-pens are required inside the stall.

SPONSORSHIPS: Please sign up to sponsor a class. Sponsorships help pay for ribbons, trophies, judges and other trial expenses. See included sponsorship form.

VENDORS ARE WELCOME FOR THE WEEKEND! There is a \$25 fee. Please indicate on your entry form if you would like a vendor space.





DIVISION A: RACING

- ALL TERRIERS MUST BE MUZZLED! Plastic basket muzzles or closed-ended cloth muzzles ONLY. Figure eight, open-ended, and Baskerville muzzles are NOT allowed, No exceptions.
- ATTENTION: JRTCA RULE FOR RACING MUZZLES NO COLORED MUZZLES ALLOWED. White, Black, Brown/Tan, & Clear muzzles are allowed.
- Terriers MUST ENTER both flats & hurdles AND FINISH in both, at least one flat race AND one hurdle race and place first in at least one of their finals to compete in Championship races.
- > Seniors run over low hurdles, up to 8 inches.
- No cross-entering between regular Adult classes, Veteran classes, Senior classes, or sanctioned and non-sanctioned classes.
- > Races will be run in the sequence posted in this Trial Premium.
- Please HAVE YOUR TERRIER ON DECK AND MUZZLED. Please listen for class announcements! If you need assistance please ask; we are here to help.
- > PLEASE BE CONSIDERATE OF OTHER COMPETITORS.
- > 3-4 and 4-6 month puppies do not run hurdles or qualify for Puppy Championship.

Adult and Veteran Races over higher hurdles, over 8" up to 16". **No 3-4 or 4-6 month Puppy Steeplechase Races.**

DIVISION B: CHILD & YOUTH All Child/Youth Classes Sponsored by Desi Blondeel-Timmerman

Child and Youth Handler classes will be the first Conformation classes in the ring. Child Handler will go first followed by Youth Handler, then Conformation.

The Child/Youth Handler program must handle the <u>SAME</u> terrier in all the Child/Youth Division classes entered. The intention of this Division is for the Child/Youth to have a positive experience. They should have a basic knowledge of the history of the Jack Russell Terrier as well. This information is available on the Jack Russell Terrier Club Of America's website. <u>www.therealjackrussell.com</u>.



For those terriers entered in the Child/Youth Handler Division and in the Go-To-Ground Division, please remember that the terrier MUST run their SANCTIONED Go-To-Ground class <u>BEFORE</u> the Child/Youth Handler Go-To-Ground class(es).

Reminder!

- Class 47 **Child Handler –** Open to any youth aged 5 through 9, handling a Jack Russell Terrier, six months of age or older. This class is offered as an introductory experience in handling and learning about the Jack Russell Terrier. Judged on the child's ability to present his/her dog and beginning knowledge of the Jack Russell Terrier. Quality of terrier is NOT to be considered.

A challenging GTG course with a series of false entrances and/or false tunnels and dens. Open to any Jack Russell Terrier, 6 months and older. One second per foot of tunnel to reach quarry; may leave and re-enter earth several times until the quarry is reached; must work quarry for one full minute without a break in work and without leaving quarry. May switch from one type of work to another without penalty.

Open Super Earth Classes are NOT Champion Classes. You must pass the Open class and submit your paperwork to the JRTCA to compete in the Super Earth Certificate Classes at future trials.

The terrier with the fastest time is not necessarily the winner.

DIVISION G: BRUSH HUNT PLUS

(NON-SANCTIONED)

Your dog will run in an area with straw bales, cardboard boxes, garbage bags filled with paper, other common things found in your garage or yard, and an agility tunnel. When the judge calls you and your dog into the ring, you'll enter and go straight to the start area. You will wait there until the Judge says it is OK to start. You'll then remove your dog's collar and leash and release your dog. Your time starts when your dog's or your feet leave the start area. During the 2:00 minute maximum run time your dog will be required to find the rat, go through the agility tunnel, and climb up on anything in the ring stable enough for them to climb on. The three



requirements can be completed in any order. You may encourage you dog to move anywhere in the ring but you may not touch your dog, any items in the ring, or step over anything until they find the rat. Time stops when all the requirements are completed or the 2:00 minutes are up. Placement will be based on time.

There will be three hidden rat containers made of PVC pipe in the ring during each run. One will be empty, one will contain rat litter, and one will hold the rat.

When your dog finds the rat, you must let the Judge know by clearly calling RAT. If the Judge confirms that it is the rat praise your dog for doing the right thing then restrain your dog while the rat is moved to safety. You may then release your dog to finish any remaining requirements. If the Judge says the call is not a rat, your run is done and an NQ score will be assessed.

Time starts when paws touch the ground and stops when the handler believes they have located the quarry. That's when the fun begins. **Champion and Reserve are based on judge's choice, not on time. (Non-Sanctioned)**

- Class 168 Adult Terrier High Point Open to adult Terriers 1 year and older, MUST compete in Working or Open Conformation (Division C), plus at least four additional classes from these events: Go-to-Ground, Super Earth, Racing Flats, Racing Hurdles, Trailing & Locating, Brush Hunt, and Urban Warfare.
- Class 169 Veteran High Point Open to Terriers 6 years and older only. MUST compete in the Veteran Terrier conformation class (or equivalent), plus at least four additional classes from these events: Go-to-Ground, Super Earth, Racing Flats, Racing Hurdles, Trailing & Locating, Brush Hunt, and Urban Warfare
- Class 170 **Senior High Point –** Open to Terriers 9 years and older only. MUST compete in the Veteran conformation class (or equivalent), plus at least four additional classes from these events: Go-to-Ground, Super Earth, Racing Flats, Racing Hurdles, Trailing & Locating, Brush Hunt, and Urban Warfare
- Class 171 **Companion/Rescue High Point –** Open to Spayed & Neutered Terriers and Rescued Terriers. Dogs MUST compete in the Spayed/Neutered Class <u>or</u> the Companion & Rescue Terrier Conformation Class, plus at least four additional classes from these events: Go-to-Ground, Super Earth, Racing Flats, Racing Hurdles, Trailing & Locating, Brush Hunt, and Urban Warfare

- Class 172 **Novice Terrier/Handler High Point –** Open to Novice Adult Terriers & Novice Handlers, where the Gemboree is their FIRST trail experience. Points are accumulated through the following classes: Conformation Class 93, Go-To-Ground Class 107 or 110, Super Earth Class 126, Trailing & Locating, Brush Hunt, Urban Warfare, and Racing.
- Class 173 **Other Breed High Point –** Open to any breed other than a JRT. Your dog must compete in a minimum of five (5) events, both days, from the 'other breed' classes listed.
- Class 174 **Games Master High Point –** Open to dogs that compete in all three Division I Games. Highest accumulation of points from the 3 games over BOTH DAYS will be Champion and Reserve. May cross enter between this class & any other high point.
- Class 175 **Terrier Terra Triumph!** Test your terrier's tracking & gaming skills and have some fun doing it! Open to dogs 6 mo & older. To be eligible, dogs MUST compete in <u>ALL</u> of the following: GTG, SE, T&L and Brush Hunt, <u>BOTH</u> days. Champion & Reserve will be the highest combined scores from the weekend; to be awarded Sunday. Ties will be settled by best time in GTG. (Times & placements from GTG do not include the novice tunnel). May cross enter between this class & any other high point. Score sheet will be in registration packet. **No Entry Fee!**




